Make-A-Wish San Diego grants the wishes of children between the ages of 2.5 and 18 who have been determined to have a critical illness and qualify for our wish program. A total of 223 wishes were granted during the year. Total cost of wishes granted for the fiscal year were \$3,843,357. Of this amount, \$1,096,985 was contributed by various vendors who provided In-Kind contributions of services such as travel and travel services, transportation, lodging and other services, and use of facilities to complete a child's wish. The chapter provides Wish Assistance to Wish Kids coming to San Diego for their wish. The organization received \$70,400 of Wish Assist Income to help defray the costs associated with hosting 263 kids and their families. This year the wish types included travel (79%, meeting celebrities (8%), shopping
