Make-A-Wish San Diego grants the wishes of children between the ages of 2.5 and 18 who have been determined to have a critical illness and qualify for our wish program. A total of 209 wishes were granted during the year. Total cost of wishes granted for the fiscal year were \$3,782,779. Of this amount, \$655,230 was contributed by various vendors who provided In-Kind contributions of services such as travel and travel services, transportation, lodging and other services, and use of facilities to complete a child's wish. The chapter provides Wish Assistance to Wish Kids coming to San Diego for their wish. The organization received \$63,550 of Wish Assist Income to help defray the costs associated with hosting 263 kids and their families. This year the wish types included travel (69%), meeting celebrities (10%), room

Make-A-Wish San Diego grants the wishes of children between the ages of 2.5 and 18 who have been determined to have a critical illness and qualify for our wish program. In addition to granting wishes for children in San Diego, the chapter gave \$100,000 to support the Make-A-Wish Foundation of America's Wish Fulfillment Fund that supports chapters in need of additional wish granting funds. With the average cost of a wish being \$10,000, this resulted in 10 additional wishes for children whose chapter(s) may not have been able to grant their wishes.
