Make-A-Wish San Diego grants the wishes of children between the ages of 2.5 and 18 who have been determined to have a life-threatening medical condition and qualify for our wish program. A total of 225 wishes were granted during the year. Total cost of wishes granted for the fiscal year were \$4,113,813. Of this amount, \$1,077,213 was contributed by various vendors who provided In-Kind contributions of services such as travel and travel services, transportation, lodging and other services, and use of facilities to complete a child's wish. The chapter provides Wish Assistance to Wish Kids coming to San Diego for their wish. The organization received \$66,225 of Wish Assist Income for providing these services.
