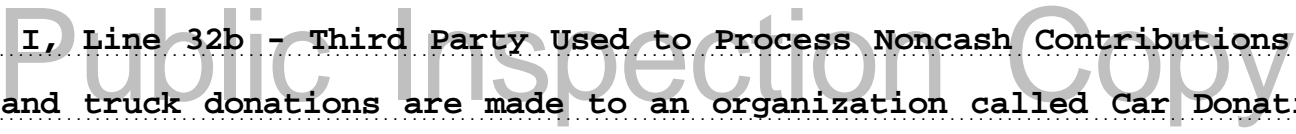

Make-A-Wish San Diego grants the wishes of children between the ages of 2.5 and 18 who have been determined to have a critical illness and qualify for our wish program. A total of 220 wishes were granted during the year. Total cost of wishes granted for the fiscal year was \$3,645,713. Of this amount, \$970,210 was contributed by various vendors who provided in-kind contributions such as computers, building materials, and other goods as well as travel, transportation, lodging, and use of facilities to complete a child's wish.

The chapter provides Wish Assistance to Wish Kids coming to San Diego for their wish. The organization received \$91,750 of Wish Assist Income to help defray the costs associated with hosting 281 kids and their families. This year the wish types included travel (67%), meeting celebrities (10%), room or backyard makeovers (9%), shopping sprees (8%), and the remaining 6% was a variety of wishes.

The Foundation's Board of Directors has delegated the primary review of the form 990 to the finance committee (FC).
